All of the shares will fully vest on September 17, 2012, 2013, 2014 or 2015 if the average closing price for the common stock of the 30-day period ending on the day prior to such date is greater than or equal to \$28.70, \$30.34, \$31.98, and \$33.62 respectively. If the Performance Shares do not vest on or prior to September 17, 2015 they will be forfeited.
